The United ACO Program

By now, you have enrolled and completed the practice survey review. This program provides a Care Management fee to all PCPs, which will be distributed on a quarterly basis and is guaranteed for the first year. The second and third year is guaranteed as long as the group meets its clinical services requirements. The second and third year requires meeting the Quality targets.

Clinical data reports will be provided quarterly except for hospital and ER discharge reports, which will be sent every two weeks.

Who in your office should get these reports?

- When you receive the discharge reports, each listed patient **must** be contacted and when necessary, scheduled for a follow-up appointment.
- For the quarterly gaps in care report, appropriate outreach documentation and follow-up is required, i.e. mammograms, HgbA1c, etc.
